Old Business Highlights –

**Maple Street Dredge Transfer Station Legal Fund** – Committee is working the letter. It will be reviewed, approved and sent out to neighbors. An account is being set up in Wachovia Bank to handle monies. Board of Zoning appeals hearing still not set. Community feeling is Dave Hansen still wants the Maple Street site for neighborhood programs. Jim Wood says the current zoning with proffers should stay and not be changed to P-1 (preservation). He felt the proffers are stronger restriction than what P-1 has. Todd questioned why P-1 with similar restrictions couldn't be established.

**Clean the Bay Day** – Jeannie Winters did a great job coordinating. Beach looks great. Ditch behind Food Lion was worst part of clean-up.

New Business Highlights-

**Ocean Park Floatilla** - Ocean Park is having problems with facebook/flashmod event. Hundreds are showing up at Memorial Day to party on beach, boats and inner tubes. They stay all day and create havoc when they leave intoxicated. OPCL is looking at what can be done to prevent this event. CSBTS should watch that it doesn't just move to our beach.
